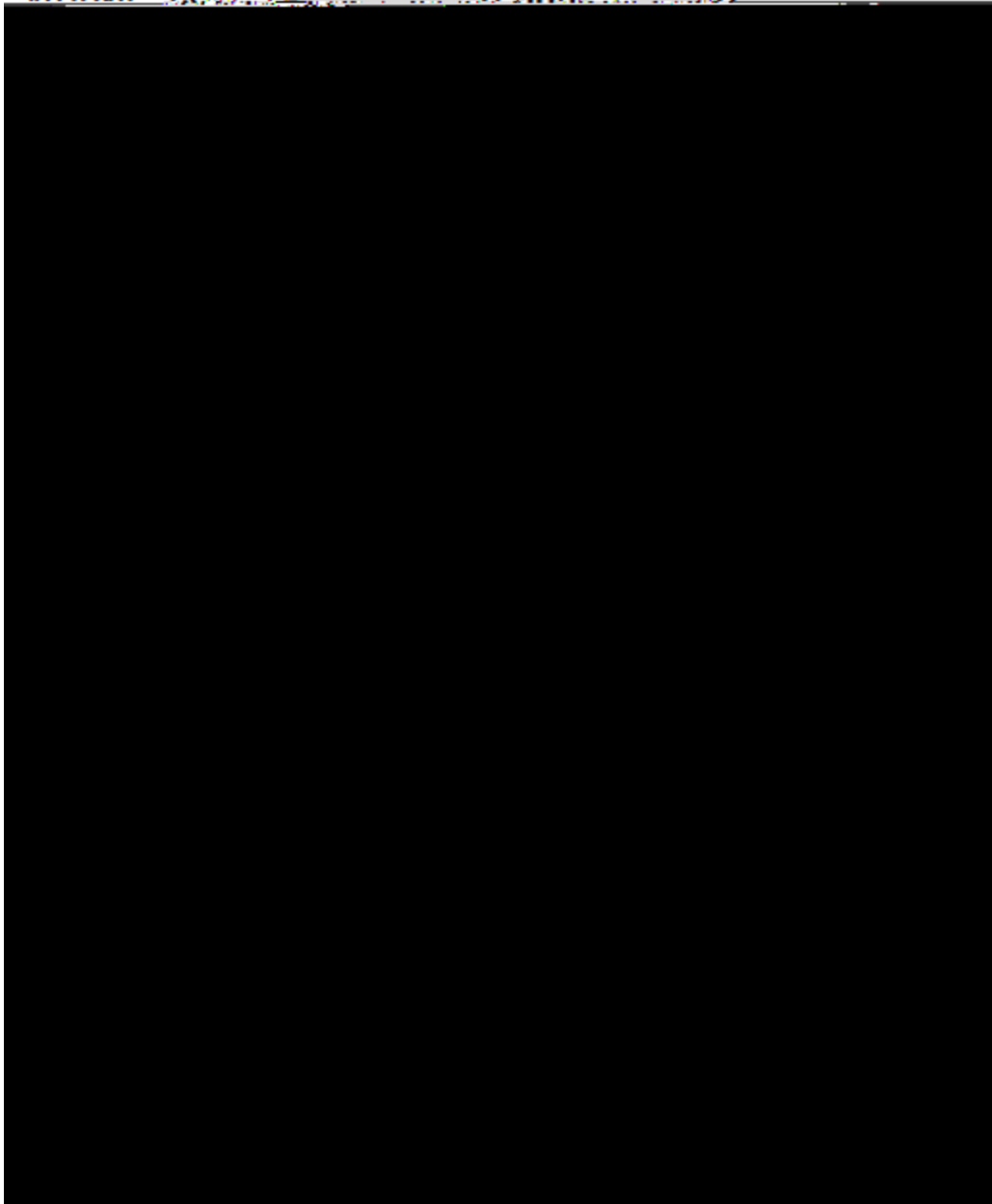

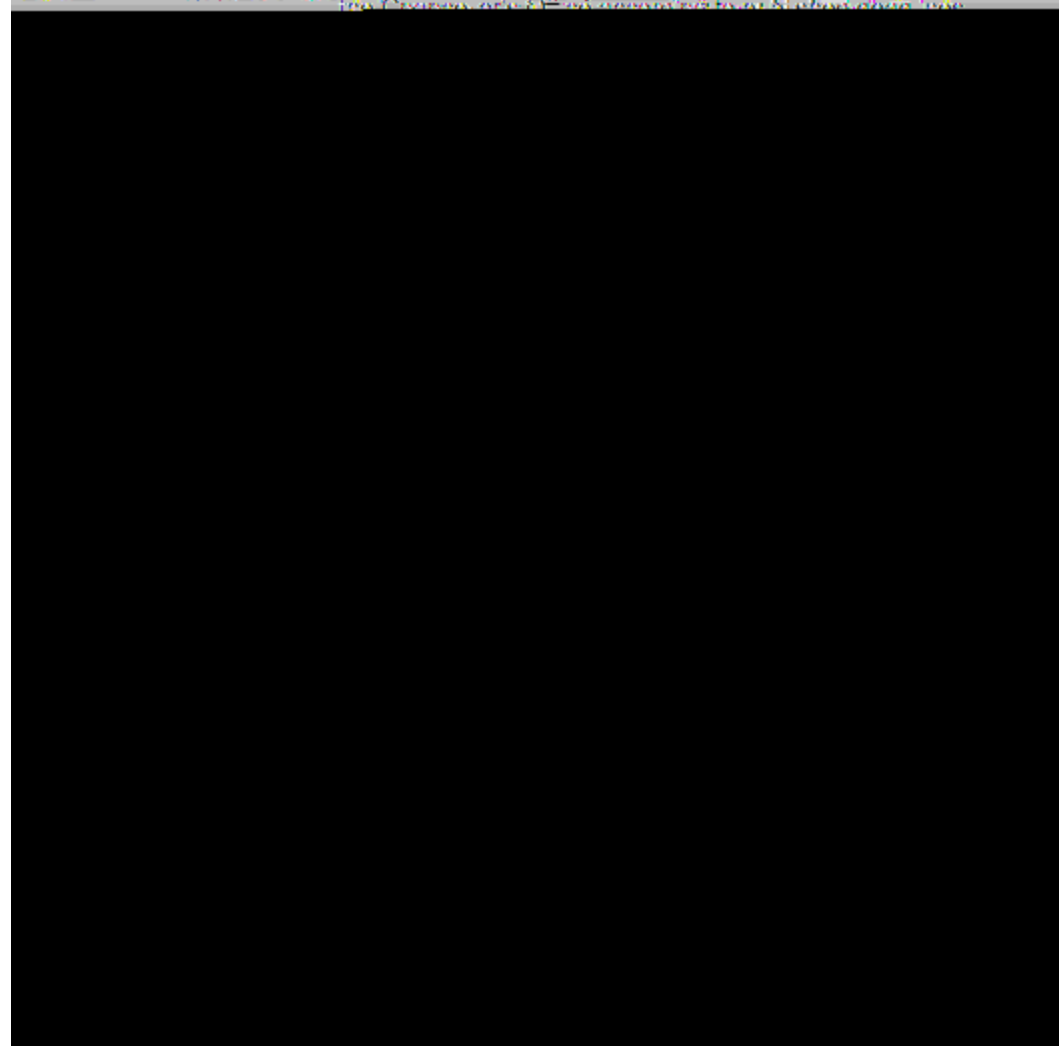

~~Section 4. Statement of Interest. The code reviewing body shall instruct all designated employees Place of Filing. The code reviewing body shall instruct all designated employees within its code to file statements of interest with the agency's conflict of interest code. The Executive Director shall be responsible for collecting the statements of interest from all designated employees in their areas and forwarding them to collecting the statements of interest from all designated employees in their areas and forwarding them to~~



confirmation or appointment, or the date of resignation, or their true residence as of the date of assuming office or the date of leaving office.

(C) Contents of Annual Statements. Annual statements shall disclose any reportable assets, interests in real property, income and business positions held or investments made by the candidate or the candidate's spouse or dependent child, or any reportable income received by any reportable person in the system of care, beginning on the date of the candidate's date of becoming a firm registrant or date of assuming office.

(D) Contents of Learning Objectives Statement. Learning objectives shall be prepared by the candidate or the candidate's spouse or dependent child, or any reportable person, beginning on the date of the candidate's date of becoming a firm registrant or date of assuming office, and shall be filed and the date of leaving office.
